



Position: Compressed Air Intervention Supervisor

Reports to: Hyperbaric Project Manager / Director of Operations

Key Activities:

- Supervising low and high pressure interventions using air, mixed gas and saturation modes.
- Manage the construction and implementation of PVHO systems including saturation mode systems.
- Interface with clients throughout the project life including marketing and estimating support (technical), planning, scheduling, submittals, on-site work, project closeout.
- Managing crews to perform hyperbaric operations including cutting, welding, cutting head reinforcement/renovation, boulder fracturing and removal, and stone crusher repair in addition to routine tool inspection, replacement and maintenance.
- Develop project specific operations manuals and protocols.
- Provide technical consultation to BDS clients.
- Assist in crew scheduling as needed; Solid understanding of job costing and general accounting skills;
- Ensure that the companies safety Program is implemented and effective;
- Maintain appropriate certifications and awareness of developing technology;
- Collaborate and cooperate with project teams and team leaders;
- Other duties as assigned;

Ability Requirements:

- At least five years' experience in mixed gas and saturation diving operations and three years tunneling operations.
- Must have an extremely advanced understanding to gas laws, gas physics, decompression tables (US Navy diving, OSHA tunneling, French tunneling, German tunneling)
- Flawless communication skills.
- Effectively manage multiple projects - must be able to multitask and delegate.
- Bi-lingual preferred (English/Chinese, English/French, English/Spanish, English/Russian, and English/Portuguese).
- Superior computer skills (Microsoft Office suite, CAD experience preferred)
- Advanced understanding of all OSHA regulations related to tunneling.
- Working in the field at is often physically demanding. The following list describes the minimum daily requirements for all field personnel:
- Performing physical activities that require considerable use of your arms and legs and moving your whole body, such as climbing, lifting, balancing, walking, stooping, and handling of materials;



- This is an emergency response organization and 24/7 support will be required at times. Domestic and international travel, long deployments and long shifts with non-standard break times can be expected.
- Work in a variety of weather conditions with exposure to the elements;
- Must have vision equal to or better than is required for driving;
- Must have good hand-eye coordination;
- Must be able to hear adequately enough to be alerted by horns, sirens, shouting, or any other noise that is meant to convey a safety warning;
- If a corrective device is required to achieve this level of hearing, the employee must be able to wear PPE without interfering with the corrective device or the required PPE;
- Must have good balance and equilibrium; Climb ladders or steps to reach objects;
- Must be able to work in confined or enclosed spaces;
- Must be able to sit or stand for long periods of time;
- Must be able to wear a hard hat, safety glasses, gloves, and safety-toed boots;
- Must be able to walk moderate distances to reach work area (1/2 mile or more);
- Understand and follow oral and written instructions;
- Must have common sense and be mentally stable and competent;
- Must work cooperatively with others;
- Must have a positive attitude;
- Work safely without presenting a direct threat to self or others;
- Must be committed to contributing to a culture of safety, looking out for yourself and others;
